Rules of Conduct and Commitment

1. ATTENDANCE/COMMITMENT

Attendance at the Welcome Student Networking and Parent Meeting, December Community Service Project and Graduation is mandatory. Attendance at all sessions is expected. Check session dates prior to submitting the application to ensure you meet the attendance requirement.

Young Leaders is a 9-month commitment. Sessions are held once a month on the second Wednesday of each month during the school day. Commitment to the program is essential to successful completion. Students are allowed to miss one seminar day. If more than one session is missed, or any of the mandatory days they will not graduate from the program.
